DECLARATION OF ADRIANNE D. YOUNG

1. I AM 47 years old and am the Petitioner.

2. I declare I am writing this declaration in an effort to facilitate a safe environment in which Adelaide V. Young can visit with her father Erik B. Cannella only when he is sober and supervised. I would like to stay safe from Erik's hyper-focused and unrelenting negativity toward me.

The physical, mental and cognitive effects of Erik's extensive, daily, heavy drinking has made Adelaide's visits destructively toxic and physically dangerous. Of late, visits have been filled with abusive narrative, physical endangerment, and neglect. After the events 01/22/2022, it was clear that to allow an unsupervised visit between Adelaide and Erik B. Cannella in his current struggle with alcoholism would be neglect her emotional and physical well being.

1 Erik's short term memory loss is alarming and exposes Adelaide to neglect. He forgets
2 important details about Adelaide's care. Erik's ability to remember conversations and events is
3 impaired by the effects of long term alcohol use. Erik is no longer able to say nice words in
4 conversant tones about me around Adelaide, especially when it comes to me. Erik's
5 conversation has become vociferously acrimonious since I became romantically involved with
6 Leland Holmes.

8 On Saturday 01/22/2022 Erik was spending the night in Leavenworth to visit Adelaide. At 5:00
9 PM, I dropped Adelaide off to my neighbor/landlord's house where Erik was staying. At 5:22 PM
10 Erik sent an abusive text to me in favor of concentrating on Adelaide, whom he had not seen in
11 over a month.

12 At around 6:00PM Erik contacted me and asked for Adelaide's overnight bag. Not 10 minutes
13 later, Leland Holmes and I walked the 1/8 mile up to the house where Erik was staying to deliver
14 the overnight bag. Erik and Adelaide were in the driveway outside the house preparing to go into
15 Leavenworth for a pretzel.

16 Erik took the overnight bag and put it behind a case of wine in the trunk of his car. Erik made
17 repetitive statements about how "happy" he was that Leland and I were together.

18 About an hour and a half later, Erik and Adelaide had returned to the house and the basement
19 guest room. Erik again contacted me and asked for Adelaide's overnight bag. When I sent a text
20 reminding him that he had the bag, Erik called via video chat, confused and indignant and asked
21 how Leland and I were able to deliver the bag without his knowledge. He had no recollection of
22 the conversation in the driveway less than two hours earlier. He did not know there was an
23 overnight bag for Adelaide in the trunk of his car.

24 In the background of the video chat, Adelaide was naked. She looked cold and tense. She was
25 in earshot and looking into the phone from a chair next to Erik. When I politely reminded Erik
about the bag. Erik then proceeded to accuse me of "beating" him "within an inch of his life" and
of "raping" him. He stated that Adelaide's conception was from my rape of him. He called me a
murderer.

I asked Erik to change the subject of the conversation for Adelaide's benefit and he stated that
he was "So fucking done with caring."

I suggested that Erik focus on taking care of Adelaide and get her dressed. About 20-minutes
later, Erik called and said, "I hate that you are a liar and your daughter wants to come home."

Leland and I promptly walked up to the house and to the basement door. I opened the door and
saw Adelaide sitting on Erik's lap. She was naked with a towel draped over her shoulders and
appeared frightened and uncomfortable. Erik looked at me and said, "I don't know you." The
expression on Erik's face did not indicate familiarity or recognition of me, his mate of 14-years.

Once I was inside and dressing Adelaide, Erik stood in the doorway facing Leland and stated
that we were all going to sit down and that I was going to listen to what I had "done" to him.
Leland stated that we were not going to stay. Erik and Leland then began to shout at each other.
Leland stated that we were leaving. I heard Leland tell Erik to stay out of his personal space.

1 Erik entered Leland's personal space. Erik stated that we needed to hear "what she's done."

2 I was not able to leave with Adelaide as Erik blocked our exit.

3 Leland physically held Erik still while I moved past Erik toward the door. The situation was
4 urgent enough that I was unable to get Adelaide's boots and coat before leaving.

5 Once home, Adelaide complained about being cold and hungry – Erik had fed her only a soft
6 pretzel from the brewery for dinner.

7 Later that evening Erik called the Chelan County Sheriff's office. Deputy Biggar, who responded
8 to Erik's call o the Chelan County Sheriff's Department expressed concern that Adelaide had
9 been in Erik's presence unsupervised and advised that I seek a protection order to keep him
10 from driving or spending time with Adelaide while intoxicated. In the incident report, he and other
11 deputies noted alcohol on Erik's breath. A case report for incident #22C00663 dated 01/22/22 is
12 attached and titled Attachment A.

13 The incident on 01/22/2022 scared Adelaide and she has since volunteered that she does not
14 want to see her or talk to her father when they alone together.

15 Erik's visit to Leavenworth from Sunday 11/12/21 to 11/14/21 was frightening to me and
16 disappointing for Adelaide. Adelaide had asked me if Erik could come and stay the night. Due to
17 my physical fear of him, I had previously barred him from staying in the house. I acquiesced to
18 Adelaide's request. I called in Adelaide absent from school on Monday, 11/13/22 so that she and
19 Erik could spend the day together. Erik spend the morning of 11/13/22 in town and then spent
20 the afternoon of 11/13/22 passed out in her bed while she watched shows on the iPad. That
21 night, Adelaide would not sleep next to Erik because the alcohol on his breath was so strong.
22 Late that night, after I had gone to bed, Erik knocked on my bedroom door and asked to talk to
23 me. When I stepped out to the great room to talk to Erik, he proposed we have sex. I declined,
24 returned to my bedroom, and locked my door.

25 Later that night, Erik attempted to enter my room and twice tried the locked door. He wordlessly
shouted in frustration when he could not enter my room. I lock my doors because Erik has
stated several times that he cannot control his emotions around me. This statement frightens
me, as Erik does not display self control in his communication or with alcohol.

I am asking for supervised telephone and video chat visits because Erik does not contain his
negativity and toxicity toward me. When he is asked to change his conversation for Adelaide's
benefit, Erik will say, "She can handle it." Erik has stated on several occasions that he does not
care what conversation Adelaide hears and that "She can handle it."

After speaking with Erik via video chat on 02/15/2022, Adelaide no longer asks to speak with her
father and refuses to video chat with him alone. Prior to 02/15/2022 Adelaide would refuse to
speak with her father unless I or someone else were actively involved the conversation. At
present she will only speak to Erik if she is cajoled and he has someone with him in the
conversation.

During their video chat visit on 02/15/2022, Erik began his conversation with Adelaide by asking
if I had company over in the house. This put her in the middle of a conflict he instigated with

1 Leland Holmes on 01/22/22. He then falsely accused me of keeping Adelaide “away from her
2 family,” by not allowing her to speak to his family via video chat. Adelaide had visited with Erik’s
3 family via video chat on 02/13/2022.

4 During the conversation on 02/15/2022, he alluded to taking Adelaide to stay “for a while” at his
5 parents house, who he had as recently as September 2021, accused of physically abusing him
6 as a child. He has also alluded to possible regressed memories of sexual abuse by one of his
7 parents.

8 I began to feel that Erik was not capable of looking after Adelaide’s physical well being after an
9 incident while Adelaide was visiting Seattle on Thursday, 09/23/21. On the afternoon of
10 09/23/21, while playing at the park with Erik, Adelaide exasperated her nursemaid’s elbow– a
11 painful ligament slip also known as radial head subluxation. It is an injury she easily sustains
12 and it painfully immobilizes her arm. Despite her obvious pain and subdued mood that I
13 observed on video chat, Erik waited until the next day to buy or administer pain medication and
14 did not seek medical attention for Adelaide.

15 Adelaide returned to Leavenworth with an immobile left arm and in unnecessary, acute
16 discomfort. The simple fix for this condition can be found on YouTube. Erik blamed his inaction
17 of taking care of Adelaide on me and took no responsibility for her condition.

18 Erik’s ability to “sound” sober and drive while intoxicated has allowed him to work and socialize
19 under the influence of alcohol for decades. However, In February 2019, Erik and I were set to
20 rent out a catering kitchen in Blue Spirit’ Distillery’s new space when he was fired from Blue
21 Spirits for alcohol consumption on shift. He was banned from their property because of his
22 repeated attempts to contact Blue Spirits’ employees after he was fired.

23 After the truth of Erik’s alcoholism became more public, Erik’s consumption and behavior
24 became more physically expressive. On 3/7/2019 Erik lunged at me in the kitchen of our home
25 while I held Adelaide in my arms. When I looked at him, he said into my face, “You don’t know
what I think about doing to you.” He had lunged at me so violently on 08/15/2015, that I felt
forced to physically defend myself.

On Wednesday, 06/12/19, at the Icicle Center for the Arts, while we were in the kitchen cooking
for a Chef Fest fundraiser called First Night Bite, Erik held Adelaide and kicked at my feet as I
carried a large pot of boiling hot water. He elbowed me while I used a kitchen knife. I was
unnerved that he had held Adelaide as he tried to hurt me. I was unnerved that he blamed me
for his actions – that his actions were because I had “beaten” him. I fear for my life when I am
around Erik because he blames me for his condition and does not take personal responsibility
for his own state of mind.

In the morning of 02/01/21, Erik was heavily intoxicated and told me to “shut up bitch” in front of
Adelaide. When I calmly asked him to leave the house, he refused. I took a walk. When I
returned, Erik continued to be verbally abusive. The Chelan County Sheriff’s deputy who
responded to Erik’s wellness check in 2019 had asked that I call 911 if there were a time I felt
Erik was out of control. Erik had consumed the better part of a case of wine within 24 hours. I
called 911. Incident report #21C01033 is attached and titled Attachment B.

1 Erik has stated that since Adelaide is a child from my act of “raping” him, he has a problem
2 “connecting” with Adelaide. Erik’s comfort with accusing me of rape, murder, and domestic
3 abuse in front of Adelaide does not reflect that he holds anything sacred. This deficiency of
4 observing the sacred has allowed Erik to say anything he feels will hurt me. This lack of sacred
5 truth in favor of hurting me makes me fear for Adelaide and my physical well being.

6 When not under a protective order, Erik sends me multiple daily texts threatening to “take”
7 Adelaide. He threatens legal action against me, he accuses me of murder, domestic abuse, and
8 rape and states judgements about my personality. Screenshots of such conversations are
9 attached and titled Attachment C.

10 Erik accuses me of “murder” because my late boyfriend committed suicide in front of me.

11 Erik’s memory, like the statements he has made to the CCSD in each of the three attached case
12 reports, is riddled with inconsistency, fallacies, and contradictions. The three CCSD case reports
13 reflect a long running and devolving problem with alcohol that have effected his behavior.

14 Erik has expressed via text, concerns about his brain health and his mental wellbeing is a
15 consistent source of concern. Erik has texted me several times over 2022 to say “good bye.”
16 Suicidal ideation has been a long running vein of conversation for Erik. On 05/7/2019, Chelan
17 County Sheriff’s Department performed a wellness check on Erik after he spent the evening
18 cooking for an event while dinking heavily. Erik had called me through the event stating he was
19 in emotional crisis, which is something he did at every event he cooked solo for in 2019. I told
20 him to please call friends and family as calling me never seemed to alleviate the issue and only
21 seemed to serve as an excuse to verbally abuse me. He then called male friends and family
22 alluding to suicide plans later that evening. An incident report is attached and titled Attachment
23 D.

24 Erik has reported to me via text that he has a TIA – a brain injury that puts him at risk for a
25 stroke. When we met in 2006, Erik claimed to have sustained 7-concussions and maintained
that claim to friends over the past 14-years.

After years of heavy, alcohol abuse of no less than 3 bottles of wine a day, Erik’s cognitive
capabilities have profoundly diminished. I had hoped that being away from me (whom he
blames for his condition) would allow him to clear his mind and mend. However, in the year that
we have been physically separated, Erik’s physical and mental condition has worsened.

Because of his ability to sound sober when profoundly intoxicated, I am asking the court to order
Erik to use a Sober Link device before and during supervised video chat conversations and
supervised visits with Adelaide.

It would be in Adelaide’s long term best interest if Erik be tested for Wernicke–Korsakoff
syndrome – a form of alcohol-induced dementia – and general brain health so that we could set
realistic visitation expectations and arrangements that suit Erik’s condition, rather than blindly
accommodating his erratic behavior.

Based on his witnessed history of driving while intoxicated and with an open container and
because Erik’s alcohol withdrawal symptoms are both profound and obvious, Erik should not be
allowed to drive with Adelaide in the vehicle until he has completed an alcohol sobriety program.

1
2 Erik feels free to share his accusations that I am a murdered who raped and beat him to
3 anyone, even under oath. He does not see Adelaide as someone who needs to be protected
4 from the adult conversations he is compelled to have about me. These accusations are
5 damaging to Adelaide's emotional well-being.

6 Because Erik falsely states in front of his child that her conception was rape, I do not feel that he
7 holds anything, even her, sacred. Because Erik has physically threatened me, I am afraid that
8 he will eventually obtain the courage, lose the self-regulation, or obtain means to physically
9 attack me in front of Adelaide again. I am physically afraid of Erik. I am afraid of Adelaide's
10 physical and mental well-being when she is with Erik.

11 While Adelaide should always have the choice to contact her father, Adelaide is happier when
12 she is not forced or persuaded to be in contact with Erik. From 02/15/2022 to 03/05/2022,
13 Adelaide was not in contact with Erik at all, her confidence and happiness in that period was
14 observed by her teacher, Karlye Risdon whose declaration is Attachment E.


15 Erik Cannella – who could capture a room with his wit and humor, who told everyone he knew
16 and saw I was pregnant the very day the home pregnancy test showed a positive, the man who
17 years before we conceived a child promised to name it Super Fantastic Awesome Guy/Gal– is
18 being held hostage by alcoholism.

19 Given that Erik has repeatedly claimed to be in "remission" from alcohol and yet still displays
20 erratic behavior and conversation, I do not believe Erik will ever be sober until he is admitted to
21 an inpatient rehab facility. I believe any amount of alcohol diminishes his self-control. I am
22 asking that the court to order inpatient treatment, completion of a sobriety program, and mental
23 evaluation before he is considered safe to visit with Adelaide unsupervised.

24 I know that Adelaide and I would welcome a relationship with her father were he to be sober and
25 endeavoring toward brain health. If Erik does not stop drinking (as was recommended by
medical professionals in 2020 when he was a patient in a detox facility) his behavior will not
improve. At present, he is not safe for Adelaide or myself to be around alone.

Narrative

Sun Jan 23 05:18:37 PST 2022

I Deputy Jerrod Biggar was on uniformed patrol in Chelan County Washington on January 22nd 2021. At approximately 2218 hours I was dispatched to an assault call located at 262 Dempsey Road in Leavenworth, Washington. The reporting party (Cannella, Erik B. DOB 8/1/67) stated that his wife's boyfriend "shook" him by his shoulders after a confrontation at the location. Erik identified his wife as (Young, Adrienne D. DOB 9/14/74).

Erik explained that he and his wife were separated, but not legally divorced yet. He said his wife lives at 186 Dempsey Road in Leavenworth with her boyfriend "Lee." Erik did not know the boyfriends name but he was later identified as (Holmes, Leland B. DOB 11/19/76). Erik said he was currently living in Seattle but wanted to move to Leavenworth so he could be closer to their 5 year old daughter who was living with Adriane. Erik said he was staying the weekend at 262 Dempsey Road so he could visit his daughter and interview for a job as a chef at the hospital.

I contacted Erik by phone. He said today he was spending time with his daughter when she suddenly became upset and wanted to go back to Adrienne. Erik said he called Adrienne to come pick up the child as they lived within walking distance. Erik said Leland showed up with Adrienne and attacked him unprovoked. He said Leland grabbed him by the shoulders and shook him for a few seconds and told him

to "back off." Erik said Leland was much larger than him and he was scared. I asked Erik multiple times if he wanted to pursue charges for assault and he told me yes. He agreed to fill out a written statement form detailing the incident. While I spoke with Erik I noticed him repeating himself multiple times as if he was forgetting what he told me. He also spoke very slowly and seemed to be struggling with the enunciation of his words. Erik was emotional and asked to take breaks during my interview so he could collect himself. Initially I thought he was intoxicated, but he told me he suffered from head injuries.

After speaking with Erik, I contacted Adrienne and Leland to get their side of the story. I spoke with the couple at their residence and asked them to tell me what happened. Adrienne told a very similar story and said they walked to Erik's house to pick up their daughter at his request. Adrienne said when they arrived Erik opened the door but did not recognize them. She said he acted as if he did not know what they wanted and closed the door on them. He then reopened the door and invited them inside.

Adrienne said Erik was holding their daughter who was naked. She said she tried to take their daughter from him and for a moment he refused to let go. Leland said he saw this and it made him concerned. He said after Erik gave Adrienne the child he was standing between Adrienne and the door and began a verbal argument. Leland said he inserted himself into the argument because Erik was getting too close. He said he had to put his arms out to keep Erik at a safe distance.

Leland said Erik grabbed ahold of his arm so he grabbed Erik by the shoulders. Leland said he then physically moved Erik away from the door so Adrienne could leave with the child. Leland admitted to telling Erik he needed to back off. Once they were out of the house they went back home.

Adrienne said she had to turn off her phone because Erik kept sending her text messages and calling her. She told me Erik has a problem with alcohol and has been to treatment in the past. She said she did not feel Erik was in good enough condition to care for their daughter. I asked Adrienne if there was any kind of parenting plan in place. She told me no, but said they have tried to work things out themselves. She said Erik struggles because he can't remember what day it is and gets confused with calendars. I provided Adrienne with information about obtaining an order for protection from the court.

After speaking with Adrienne I went to Erik's location to drop off his written statement form. When Erik came to the door I smelled an odor of intoxicants coming from his breath. Deputy Sutton and Deputy Barnes were assisting me with

the investigation and advised they smelled the odor as well. Erik initially denied that his daughter was naked when Adrienne arrived, but then changed his mind and said she was wearing a towel. He denied not recognizing Adrienne and Leland at the door and said he invited them in without hesitation.

I told Erik how he could return the statement form when he was finished. He asked me what was going to come of the situation. I told him there was no probable cause for arrest and the case would be forwarded to prosecutor for review at most. Erik told me he was glad nothing was going to come of it and he did not want anyone to go to jail or get arrested. This was contradictory to what he told me when we spoke on the phone. Erik told me on the phone he was willing to stay in town longer if needed to aid in criminal prosecution if it was necessary.

No crime at this time.

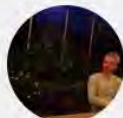



Financial, medical, and confidential reports, as described in General Rule 22, **must** be sealed so they can only be seen by the court, the other party, and the lawyers in your case. Seal those documents by filing them separately, using a Sealed cover sheet (form FL All Family 011, 012, or 013). You may ask for an order to seal other documents
